# Fee Schedule

On average, our investigations range from \$500 to \$15,000 USD total per case, with 50% upfront retainer costs ranging from \$250 to \$7500 USD. Our transparent fee schedule, listed below, provides more detail on how our retainer system works, and how we determine total cost. Please consider our fee schedule before selecting your estimated budget. IFCS Inc. requires a fractional retainer to begin working on a project, which will cover all work and expenses within the client’s allotted budget and timeframe. All consultations, estimates and services are strictly confidential. When a case reaches 80% of its retained budget, the assigned case manager will contact the client and an update will be provided outlining the results recovered. Deadlines incorporated into the investigative process are to be expected, however “rush” cases with less than 48 hours of turnover time will be billed at a rate of 1.5x base cost, due to administrative demands. Depending on further required objectives and recommendations, further retained hours can be reserved. If any of the paid retainers’ value remains unexpended due to investigative circumstances, it shall be exclusively applied as credit toward future investigative proceedings. Final report issuance will only be delivered upon receipt of the complete retainer.

After your preliminary consultation, a personalized retainer will be calculated to include the cost of administrative time, fieldwork and records retrieval and review.
